## Accreditation and Competitive Bidding

CMS has announced the second round of competitive bidding for DMEPOS will include Detroit, Warren and Livonia; Flint; and Grand Rapids and Wyoming. Included in Ohio is Akron, Columbus, Dayton and Toledo. If a pharmacy does not participate in the competitive bidding process, it will not be possible to bill Medicare for bid items. The deadline for accreditation to bill CMS for any DMEPOS (bid or nonbid) is Sept. 30, 2009. **It is necessary to become accredited by this deadline even to bill for items that are not up for competitive bid.**

### Key dates:

#### May 14

To submit a bid for Round Two, a pharmacy must be accredited or have applied for accreditation.

#### Sept. 30

Pharmacies must be accredited to bill for nonbid items.

#### Oct. 31

Pharmacies must be accredited to be awarded a contract.
